What is "Constitutional Carry"?

- Constitutional Carry refers to the second amendment right of the people to keep and bear arms.
- It is the State's reinforcement and application of that right.
- Like all our constitutional rights, it applies only to governmental interference.
- Refers ONLY to carry without a license.
 - There are a handful of places where LTC can carry, but unlicensed cannot.
- Residency is not a prerequisite.

Who can carry in Texas?

21 years old or older

Not prohibited from purchase/ownership by Federal or State law

The following are PROHIBITED:

- Federal Prohibitions:
 - Felons (Imprisonment for more than 1 year)
 - Fugitives (over State lines)
 - Addicts
 - Mental Defective (Adjudicated)
 - Illegal or Non-exempt Aliens
 - Dishonorably Discharged
 - Protective Order
 - Domestic Violence Conviction

Who can carry in Texas? (Continued)

State Felony Conviction

Misdemeanor Assault (Bodily Injury)

Misdemeanor Family Violence

Respondent in a Protective Order

Deadly Conduct (Misdemeanor)

Terroristic Threat (Misdemeanor)

Misdemeanor Disorderly Conduct (Discharge or Display)

What can you carry under this new law?

This law applies to <u>handguns</u> only.





- Refers only to public/non-prohibited places
- Must be carried and maintained in a holster
- Must not be intoxicated
- Must not be committing a crime (other than fine only traffic) while carrying.
- Certain Locations









What are the limitations?

Must be carried and maintained in a holster

• Sec. 46.03. PLACES WEAPONS PROHIBITED

- Schools (Primary and Secondary) – Including school events.
- Colleges and Universities Including school events.
- Polling Places (Voting in progress).
- Courts and Court Offices.
- Government Meetings.
- Racetracks (Parimutuel Wagering).
- Secured Area of Airports.
- Within 1000 feet Execution Site.
- Professional Sporting Events
- Amusement Parks
- Correctional Facilities
- Civil Commitment Facility
- Mental Hospital.
- Hospital and Nursing Homes.
- Bar (51%)

WEAPONS PROHIBITED

PURSUANT TO SECTION 46.03, PENAL CODE (PLACES WEAPONS PROHIBITED), A PERSON MAY NOT CARRY A FIREARM OR OTHER WEAPON ON THIS PROPERTY.

ARMAS PROHIBIDAS

HANDGUNS PROHIBITED

PURSUANT TO SECTION 30.07, PENAL CODE (TRESPASS BY LICENSE HOLDER WITH AN OPENLY CARRIED HANDGUN), A PERSON LICENSED UNDER SUBCHAPTER H. CHAPTER 411, GOVERNMENT CODE (HANDGUN LICENSING LAW), MAY NOT ENTER THIS PROPERTY WITH A HANDGUN THAT IS CARRIED OPENLY.

CONFORME A LA SECCIÓN 30.07 DEL CÓDIGO PENAL (TRASPASAR PORTANDO ARMAS DE FUEGO) PERSONAS CON LICENCIA BAJO DEL SUB-CAPITULO H, CAPITULO 411, CODIGO DE GOBIERNO (LEY DE PORTAR ARMAS), NO DEBEN ENTRAR A ESTA PROPIEDAD PORTANDO UN ARMA DE FUEGO.

- 30.06 and 30.07 Signage:
- License Holders

What is Hays County's position on enforcement?

Plain language:

There needs to be a nexus to a lawful investigative detention or arrest for a criminal offense.

Reasonable belief (supported by facts and circumstances) that the disarming is a necessary safety precaution.
